Pool 999 (Liquid Asset Pool)

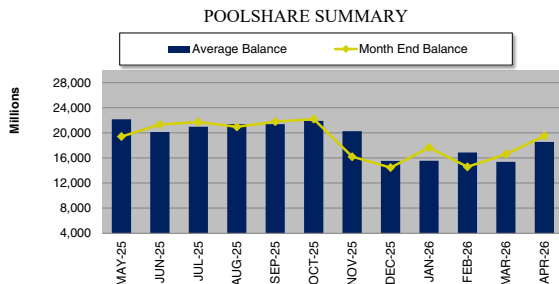
PORTFOLIO OVERVIEW

Treasury created Pool 999 for those Commonwealth agencies and funds with a very low investment risk tolerance. The pool seeks to maintain a stable net asset value per share of \$1, by investing exclusively in fixed income securities, primarily of short duration. It is designed to generate income while minimizing investment volatility by protecting principal and maximizing availability of balances through ownership of only very liquid assets.

Pool 999 is managed by Treasury's investment staff and consists of high-quality fixed income securities, primarily of short duration. As of April 30, 2026, 99.88% of the pool's assets are invested in the Consolidated Cash Pool (CCP), a short-term investment vehicle. The remainder of the pool's assets are invested in Commonwealth Time Deposits* and a Bridge Loan investment. Pool 999 participants hold shares of Pool 999 and do not hold the underlying securities of the Pool.

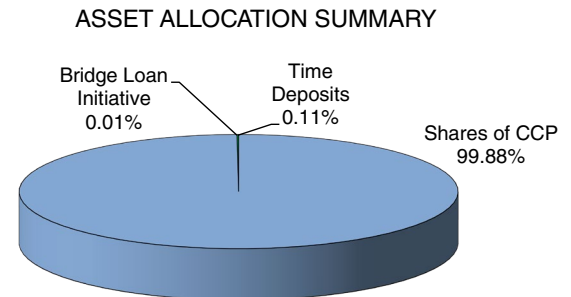
Pool 999's earnings are computed and accrued daily. Earnings (net of fees) are distributed the following month and are automatically reinvested. For the 12-month period ending April 30, 2026, Pool 999 earned \$775,979,083.
