**A) Reason for Sole Source Procurement:**

- Only a single contractor is capable of providing the service.
  - Only known source; similar services/commodities are not available from another contractor.

The Fast Tracking technology ties directly to the current unclaimed property database. This service is used to verify claimant information for expedited processing.

Ties directly to our current unclaimed property database.
